Notes:

This VPAT has been created by Deque Systems Inc upon completion of an accessibility evaluation based on an agreed statement of work. Validation testing performed between *April 3, 2020* and *May 19, 2020* was limited only to evaluation of specific accessibility issues that were already reported.

Evaluation Methods Used:

A combination of automated and manual testing techniques were employed for the accessibility assessment. Manual assessment was performed using Firefox 68.0, NVDA 2019.1 on Windows 10. Automated tools used included Deque aXe browser extension.
